# **2016 algae treatment**

**Darin Ficenec** 

#### **Copper Sulfate treatment**

- Early collection of algae treatment permits
  - Letter in mid February
  - Board Director visits in March

133 permits - up 31 households / +31%

- Submission of permit **April 5<sup>th</sup>** 2 months ahead of 2015!
- Treatment: tentatively scheduled for 1<sup>st</sup> week June.
  - 1 treatment = 2 applications, 10 days apart

Targeted completion mid-June

#### Skimming

- Contracted to complete surface skimming Targeted completion last week of June

70% paid their \$50 annual CLIA membership dues! \* First time ever this high, usually around 65% \*

149 out of 185 returned contact info forms for directory

142 out of 185 returned signed MN DNR permits

64 bay residents paid to have their shoreline sprayed for algae

103 surveys were completed out of 185 homes

## **Survey results**

#### 103 surveys were completed out of 185 homes

88 homes said they have weeds/algae by their shoreline 62 homes CAN NOT swim off docks due to weeds/algae 37 homes said they CAN swim off their docks 3 homes said they did NOT have weeds/algae

36 homes have Geese problems and need advice
